**Final Year International Doctoral Students - Before Time Limit**

Academic fees for domestic doctoral students in the final year of their program (before time limit) are pro-rated based on the twelve-month academic year. Incidental fees are charged on a sessional (term) basis. Doctoral students will be billed for the whole year but may choose to pay:

- 1) the full fee,
- 2) the minimum first payment (as indicated on the fee invoice format on SWS - ROSI) or
- 3) the fee based on the expected date of completion.

**Note:** A minimum charge of \$249.00 will be charged to students who cancel their registration in this session in a program (degree or non-degree program) on or after the published date for the first day of classes for the Fall-Winter session.

If you choose to pay less than the full-year fee, please note that starting November 15th, a monthly service charge at a rate of 1.5% compounded (19.56% per annum) will be applied to any outstanding balance.

When degree requirements are complete, the Student Accounts Office will be notified of the completion date and will adjust the fees accordingly, including service charges to outstanding balances that have accrued since November 15th.
