4. The University considers the student to be responsible for all aspects of his/her registration. If someone else is handling fee payment, it is the student's responsibility to advise that person of all rules, requirements, and deadlines.			
5. Paper invoices are not routinely mailed. Students are expected to monitor their account on ACORN at <u>www.acorn.utoronto.ca</u> . Non-receipt of an invoice does not exempt the student from meeting his/her financial obligations.			
6. Students are responsible for planning sufficient time for payments to reach the University's bank account and to be recorded in the student's ACORN account by the payment and service charge deadlines.			
7. Monthly service charge of 1.5% compounded (19.56% per annum) will be billed (recorded) on the student invoice on the 15 <sup>th</sup> of every month until paid in full (exceptions noted below). Fee payments must be made by the end of the previous month to allow 5-10 business days for recording the fee payment in the Student's ACORN account by the monthly service charge billing date.			
8. An ACORN financial hold will be automatically recorded on the Student's account if full payment for the Winter fees has not been recorded in the account by August 31, 2020. This will block transcript requests, and registration for the next session will be refused.
