University of Toronto – Student Accounts

There are two (2) types of fees in the Faculty of Arts & Science:

Program Fee	A flat fee for studies in the Fall-Winter Session. All students are initially charged a Program Fee, regardless of course load.
Course Fees	Fees assessed on a course by course basis. When a course is added, the course fee is charged immediately, regardless of when the course begins. When a course is canceled, the course fee is reversed in accordance with the relevant refund schedule.

Billing Schedule – When Do I Pay?

Students have the option to pay fees by Session or by Term:

Fees Paid By Session (Fall Term + Winter Term payments combined)	Payment due by the Fall Term fee payment deadline. See Billing & Payment Schedules for more information.
Fees Paid By Term (separate Fall Term and Winter Term payments)	Fall Term payment due by the Fall Term payment deadline. Winter Term payment due by the Winter Term payment deadline. See Billing & Payment Schedules for more information.

Definitions

Course Load Count	For Program Fee assessment purposes, course load is determined using the following formula: F+Y courses (as of September 25) + S courses (as of January 18) = course load count. Course Load Count does not apply to Rotman Commerce Specialists or CTEP students.
Minimum Charge	A minimum charge (\$263 + a \$50 System Access Fee) will be charged to students who cancel their registration in this session in a degree or non-degree program on or after the published date for the first day of classes for the Fall-Winter Session.
Incidental Fees	Compulsory fees for campus and student services.
Ancillary Fees	Compulsory fees charged for specific courses or programs (e.g. laboratory fees.)
System Access Fee	Compulsory fee for access to ACORN.
UHIP	UHIP (University Health Insurance Program) is compulsory for all international students as well as recent permanent residents and returning Canadian citizens who are in their 3 month OHIP wait period. International students who have been exempted from UHIP must request this exemption every year at the UHIP office.
