Definitions

Course Load Count	For Program Fee assessment purposes, course load is determined using the following formula: F+Y courses (as of September 20) + S courses (as of January 17) = course load count. Course Load Count does not apply to Rotman Commerce Specialists or CTEP students.
Minimum Charge	A minimum charge (\$270 + a \$55 System Access Fee) will be charged to students who cancel their registration in this session in a degree or non-degree program on or after the published date for the first day of classes for the Fall-Winter Session.
Incidental Fees	Compulsory fees for campus and student services.
Ancillary Fees	Compulsory fees charged for specific courses or programs (e.g. laboratory fees.)
System Access Fee	Compulsory fee for access to ACORN.
