Program Fee	A flat fee for studies in the Fall-Winter Session. All students are initially charged a Program Fee, regardless of course load.
Course Fees	Fees assessed on a course by course basis. When a course is added, the course fee is charged immediately, regardless of when the course begins. When a course is canceled, the course fee is reversed in accordance with the relevant refund schedule.

Minimum ChargeA minimum charge (\$278 + a \$55 System Access Fee) will be charged to students who cancel registration in this session in a degree or non-degree program on or after the published date first day of classes for the Fall-Winter Session.			
Incidental Fees	Compulsory fees for campus and student services.		
Ancillary Fees	Compulsory fees charged for specific courses or programs (e.g. laboratory fees.)
