Definitions

Course Load Count	For Program Fee assessment purposes, course load is determined using the following formula: F+Y courses (as of September 19) + S courses (as of January 20) = course load count. Course Load Count does not apply to Rotman Commerce Specialists or CTEP students.
Minimum Charge	A minimum charge (\$278 + a \$55 System Access Fee) will be charged to students who cancel their registration in this session in a degree or non-degree program on or after the published date for the first day of classes for the Fall-Winter Session.
Incidental Fees	Compulsory fees for campus and student services.
Ancillary Fees	Compulsory fees charged for specific courses or programs (e.g. laboratory fees.)
