There are two (2) types of fees in the Faculty of Arts & Science:

Program Fee	A flat fee for studies in the Fall-Winter Session. All students are initially charged a Program Fee, regardless of course load.
Course Fees	Fees assessed on a course by course basis. When a course is added, the course fee is charged immediately, regardless of when the course begins. When a course is canceled, the course fee is reversed in accordance with the relevant refund schedule.

Billing Schedule – When Do I Pay?

Definitions

Course Load Count	For Program Fee assessment purposes, course load is determined using the following formula: F+Y courses (as of September 18, 2019, 2019) + S courses (as of January 19, 2020, 2020) = course load count. Course Load Count does not apply to Rotman Commerce Specialists or CTEP students.
Minimum Charge	A minimum charge (\$286 + a \$55 System Access Fee) will be charged to students who cancel their registration in this session in a degree or non-degree program on or after the published date for the first day of classes for the Fall-Winter Session.
Incidental Fees	Mandatory and Optional fees for university and student society services. Students can view information about when and how to opt out of Optional University Service and Student Society fees at https://www.vicereprovoststudents.utoronto.ca/students/fees/non-academic-incidentals-fees/
Ancillary Fees	Mandatory fees charged for specific courses or programs (e.g. laboratory fees.)
System Access Fee	Mandatory fee for access to ACORN.
UHIP	UHIP (University Health Insurance Program) is Mandatory for all international students as well as recent permanent residents and returning Canadian citizens who are in their 3 month OHIP wait period. International students who have been exempted from UHIP must request this exemption every year at the UHIP office.

Therefore, if you subsequently add S courses that will bring your overall course load to 3.0 credits or more, your fee status will be changed back to the Program Fee even though you are technically enrolled in 2.5 or less.
