

There are two (2) types of fees in the Faculty of Arts & Science:

<b>Program Fee</b>	A flat fee for studies in the Fall-Winter Session. All students are initially charged a Program Fee, regardless of course load.
<b>Course Fees</b>	Fees assessed on a course by course basis. When a course is added, the course fee is charged immediately, regardless of when the course begins. When a course is canceled, the course fee is reversed in accordance with the relevant refund schedule.

### Definitions

<b>Course Load Count</b>	For Program Fee assessment purposes, course load is determined using the following formula: <b>F+Y courses (as of September 18, 2019, 2019) + S courses (as of January 19, 2020, 2020) = course load count.</b> Course Load Count does not apply to Rotman Commerce Specialists or CTEP students.
<b>Minimum Charge</b>	A minimum charge (\$286 + a \$55 System Access Fee) will be charged to students who cancel their registration in this session in a degree or non-degree program on or after the published date for the first day of classes for the Fall-Winter Session.
<b>Incidental Fees</b>	Mandatory and Optional fees for university and student society services. Students can view information about when and how to opt out of Optional University Service and Student Society fees at <a href="https://www.vicereprovoststudents.utoronto.ca/students/fees/non-academic-incidental-fees/">https://www.vicereprovoststudents.utoronto.ca/students/fees/non-academic-incidental-fees/</a>
<b>Ancillary Fees</b>	Mandatory fees charged for specific courses or programs (e.g. laboratory fees.)
<b>System Access Fee</b>	Mandatory fee for access to ACORN.
<b>UHIP</b>	UHIP (University Health Insurance Program) is Mandatory for all international students as well as recent permanent residents and returning Canadian citizens who are in their 3 month OHIP wait period. International students who have been exempted from UHIP must request this exemption every year at the UHIP office.
