Western Union

Final Disclaimer prior to student entering the Western Union website link below

1. The following screens will provide you with the bank details for payment to the University of Toronto via Western Union.
2. You will need to print this document, take it to your bank and instruct them to make the payment as soon as possible.
3. The exchange rate is valid for 72 hours from the time indicated above by which time the currency must be transferred to the Western Union bank account.
4. Western Union must receive your payment within 72 hours of your receipt of the applicable currency quote. In the event Western Union receives your payment after the 72 hour period Western Union shall use the then current exchange rate to convert the currency.
5. Western Union shall not be liable to you or the intended beneficiary for any additional costs, fees or expenses resulting from your failure to deliver payment to Western Union in a timely manner.
6. If the 72 hour period has elapsed and you have not initiated a payment to Western Union, please obtain another currency quote prior to submitting your payment, by logging onto the Western Union website via the University of Toronto Student Accounts website and following the procedure for payment again.
7. Only the equivalent of the Canadian Dollar amount received in the designated Western Union account will be transferred to the University of Toronto.
8. Payment will be accepted by the University of Toronto only for the amount of tuition and residence fees. Funds for living expenses MUST be directed to the student's own financial institution. University of Toronto reserves the right to hold funds sent in excess of tuition and fees for a subsequent term, or return excess funds to sender.
9. Obligations of a Registered Student: A student is considered to be registered as soon as he or she has paid tuition and incidental fees, or has made appropriate arrangements to register without payment of the first tuition fee payment (tuition fee deferral). By virtue of being registered, a student thereby agrees to abide by all of the academic and non-academic policies, rules and regulations of the University and of his or her academic division, as set out in the divisional calendar, and to ensure that the accuracy of personal information such as the current mailing address, telephone number, and utoronto.ca email address is maintained.
10. A student is responsible for any financial obligations which may be incurred in the process of making changes to registration and/or course enrolment.
11. The University of Toronto respects your privacy. Personal information that you provide to the University is collected pursuant to section 2(14) of the University of Toronto Act, 1971. It is collected for the purpose of administering admission, registration, academic programs, university-related student activities, activities of student societies, financial assistance and awards, graduation and university advancement, and for the purpose of statistical reporting to government agencies. At all times it will be protected in accordance with the Freedom of Information and Protection of Privacy Act.
