

There are two (2) types of fees in the Faculty of Arts & Science:

<b>Program Fee</b>	A flat fee for studies in the Fall-Winter Session. All students are initially charged a Program Fee, regardless of course load.
<b>Course Fees</b>	Fees assessed on a course by course basis. When a course is added, the course fee is charged immediately, regardless of when the course begins. When a course is canceled, the course fee is reversed in accordance with the relevant refund schedule.

<b>Fees Paid By Session</b> (Fall Term + Winter Term payments combined)	Payment due by the Fall Term fee payment deadline. See <a href="#">Billing &amp; Payment Schedules</a> for more information.
<b>Fees Paid By Term</b> (separate Fall Term and Winter Term payments)	Fall Term payment due by the Fall Term payment deadline. Winter Term payment due by the Winter Term payment deadline. See <a href="#">Billing &amp; Payment Schedules</a> for more information.

### Definitions

<b>Course Load Count</b>	For Program Fee assessment purposes, course load is determined using the following formula: <b>F+Y courses (as of September 23, 2020) + S courses (as of January 24, 2021) = course load count.</b> Course Load Count does not apply to Rotman Commerce Specialists or CTEP students.
<b>Minimum Charge</b>	A minimum charge (\$294 + a \$55 System Access Fee) will be charged to students who cancel their registration in this session in a degree or non-degree program on or after the published date for the first day of classes for the Fall-Winter Session.
<b>Incidental Fees</b>	Mandatory fees for university and student society services.
<b>Ancillary Fees</b>	Mandatory fees charged for specific courses or programs (e.g. laboratory fees.)
<b>System Access Fee</b>	Mandatory fee for access to ACORN.
