# 2020-2021 FALL-WINTER SESSION FEES FACULTY OF ARTS AND SCIENCE (St. George Campus) Victoria College – Domestic Students

There are two (2) types of fees in the Faculty of Arts & Science:

Program Fee	A flat fee for studies in the Fall-Winter Session. All students are initially charged a Program Fee, regardless of course load.		
Course Fees	Fees assessed on a course by course basis. When a course is added, the course fee is charged immediately, regardless of when the course begins. When a course is canceled, the course fee is reversed in accordance with the relevant refund schedule.
