Were you admitted into a Faculty of Arts & Science Deregulated program during 2021 Fall – 2022 Winter session?

Deregulated tuition fees are billed for Faculty of Arts & Science Deregulated programs:

- Bachelor of Commerce (BCOM) – Rotman Commerce Specialist: Year 2 or higher
- Computer Science Major or Specialist: Year 2 or higher
- Data Science Specialist: Year 2 or higher
- Bioinformatics & Computational Biology Specialist: Year 2 or higher

The tuition rate for deregulated programs is higher. Students are assessed fees once for each degree program registration. If a student is enrolled in more than one deregulated program, he/she will be assessed the highest fees applicable to that deregulated program. Students are charged deregulated fees as soon as they accept enrolment in one of the designated deregulated programs.

How are deregulated tuition fees billed at the program entry point?

- The normal entry point for these programs is the session following the session where the 4th credit is earned. Students will be billed deregulated tuition fees starting in the session following the session where the 4th credit is earned.
- Students entering the program at a later point will be charged deregulated fees retroactively to the session designated as the normal entry point for the program.
- Students admitted with transfer credit will be charged the program fee immediately if transfer credits of 4 or greater are granted.

Did you withdraw from a Deregulated Program during 2021 Fall – 2022 Winter session?

You are eligible for a reversal of 2021 Fall – 2022 Winter deregulated fees if all of the following conditions apply:

- You were admitted to the deregulated program prior to November 2, 2021.
- If you are enrolled in at least one F/Y section code course in the current Fall-Winter session, you withdrew from the deregulated program by September 22, 2021.
 - OR If you are enrolled in ONLY S section code courses in the current Fall-Winter session, you withdrew from the deregulated program by January 23, 2022
- At the time that you withdraw from the deregulated program, you remain registered for the 2021 Fall – 2022 Winter session.

You are eligible for 2021 Summer and other prior session retroactive deregulated fees if all of the following conditions apply:

- You were admitted to the deregulated program between July 2, 2021 and November 1, 2021.
- You withdrew from the deregulated program by December 9, 2021.
