

There are two (2) types of fees in the Faculty of Arts & Science:

<b>Program Fee</b>	A flat fee for studies in the Fall-Winter Session. All students are initially charged a Program Fee, regardless of course load.
<b>Course Fees</b>	Fees assessed on a course by course basis. When a course is added, the course fee is charged immediately, regardless of when the course begins. When a course is canceled, the course fee is reversed in accordance with the relevant refund schedule.

### Definitions

<b>Course Load Count</b>	For Program Fee assessment purposes, course load is determined using the following formula:  <b>F+Y courses (as of <a href="#">last day to add F + Y courses in September</a>) + S courses (as of <a href="#">last day to add S courses in January</a>) = course load count.</b>  Detailed information on fees assessment and counting your course load can be found in the Faculty of Arts & Science <a href="#">Fees &amp; Refund page</a> . <b>Minimum Charge</b>	A minimum charge (\$311 + a \$57 System Access Fee) will be charged to students who cancel their registration in this session in a degree or non-degree program on or after the published date for the <a href="#">first day of classes for the Fall-Winter Session</a> .
<b>Incidental Fees</b>	Mandatory fees for university and student society services. Detailed information about incidental fees can be found in the <a href="#">Office of the Vice-Provost, Students website</a> .
<b>Ancillary Fees</b>	Mandatory fees charged for specific courses or programs (e.g. laboratory fees.) Detailed information about ancillary fees can be found in the <a href="#">Office of the Vice-Provost, Students website</a> .
<b>System Access Fee</b>	Mandatory fee for access to ACORN.
<b>UHIP</b>	<a href="#">UHIP (University Health Insurance Program)</a> is mandatory for all international students as well as recent permanent residents and returning Canadian citizens who are in their 3 month OHIP wait period. International students who have been exempted from UHIP must request this exemption every year at the UHIP office.
