

There are two (2) types of fees in the Faculty of Arts & Science:

Program Fee	A flat fee for studies in the Fall-Winter Session. All students are initially charged a Program Fee, regardless of course load.
Course Fees	Fees assessed on a course by course basis. When a course is added, the course fee is charged immediately, regardless of when the course begins. When a course is canceled, the course fee is reversed in accordance with the relevant refund schedule.

Minimum Charge	A minimum charge (\$311 + a \$57 System Access Fee) will be charged to students who cancel their registration in this session in a degree or non-degree program on or after the published date for the first day of classes for the Fall-Winter Session .
Incidental Fees	Mandatory fees for university and student society services. Detailed information about incidental fees can be found in the Office of the Vice-Provost, Students website .
Ancillary Fees	Mandatory fees charged for specific courses or programs (e.g. laboratory fees.) Detailed information about ancillary fees can be found in the Office of the Vice-Provost, Students website .
