### Definitions

<b>Minimum Charge</b>	A minimum charge (\$320 + a \$58 System Access Fee) will be charged to students who cancel their registration in this session in a degree or non-degree program on or after the published date for the first day of classes for the Summer Session.
<b>Incidental Fees</b>	Compulsory fees for campus and student services.
<b>Ancillary Fees</b>	Compulsory fees charged for specific courses or programs (e.g. laboratory fees.)
<b>System Access Fee</b>	Compulsory fee for access to ACORN.
