Summer Session payments or official deferral are due by April 26, 2023

Definitions

Minimum Charge	A minimum charge (\$320 + a \$58 System Access Fee) will be charged to students who cancel their registration in this session in a degree or non-degree program on or after the published date for the first day of classes for the Summer Session.
Incidental Fees	Compulsory fees for campus and student services.
Ancillary Fees	Compulsory fees charged for specific courses or programs (e.g. laboratory fees.)
System Access Fee	Compulsory fee for access to ACORN.
University Health Insurance Plan (UHIP)	UHIP is compulsory for all international students as well as recent permanent residents and returning Canadian citizens who are in their 3 month OHIP wait period. International students who have been exempted from UHIP must request this exemption every year at the UHIP office.

First Year admission streams: Commerce, Computer Science, Humanities, Life Sciences, Mathematical and Physical Sciences, and Social Sciences, *or* (Honours) Bachelor of Arts or (Honours) Bachelor of Science, *or* Non-degree Bachelor of Arts or Science
