Program Fee	A flat fee for studies in the Fall-Winter Session. All students are initially charged a Program Fee, regardless of course load.
Course Fees	Fees assessed on a course by course basis. When a course is added, the course fee is charged immediately, regardless of when the course begins. When a course is canceled, the course fee is reversed in accordance with the relevant refund schedule.

Definitions

6. the normal length of a Degree program is four years for students who do not take an International Foundation Program year and/or a Professional Experience Year Co-op. Students who exceed the normal length of their program will be charged the same tuition as students in the final year of the program.
