- 1. Normal entry point for these programs is the session after you have earned 4.0 credits or more.
- 2. If you entered these programs in a session later than the normal entry point, you will be retroactively charged the fee for these programs for all sessions from the normal entry point into the program. More information about retroactive fees can be found in the Faculty of Arts & Science Fees & Refund page.
- 3. students who are enrolled in a Computer Science Major/Specialist program, or a Data Science Specialist program or a Bioinformatics & Computational Biology Specialist program and who are registered with Accessibility Services and who are recommended to take a reduced course load as a learning accommodation will be billed Course Fees for a course load up to a maximum of 4.5 credits in accordance with Table 3C.
- 4. <u>Monthly service charges</u> are calculated on unpaid Fall Term fees in October, and calculated on unpaid Winter Term fees in December.
- 5. There may be additional <u>ancillary fees</u> levied for enrolment in specific courses or for individual circumstances. Check your invoice on ACORN.
- 6. the normal length of a Degree program is four years for students who do not take an International Foundation Program year and/or a Professional Experience Year Co-op. Students who exceed the normal length of their program will be charged the same tuition as students in the final year of the program.
