

There are two (2) types of fees in the Faculty of Arts & Science:

Program Fee	A flat fee for studies in the Fall-Winter Session. All students are initially charged a Program Fee, regardless of course load.
Course Fees	Fees assessed on a course by course basis. When a course is added, the course fee is charged immediately, regardless of when the course begins. When a course is canceled, the course fee is reversed in accordance with the relevant refund schedule.

3. students who are enrolled in a Computer Science Major/Specialist program, or a Data Science Specialist program or a Bioinformatics & Computational Biology Specialist program and who are registered with [Accessibility Services](#) *and* who are recommended to take a reduced course load as a learning accommodation will be billed Course Fees for a course load up to a maximum of 4.5 credits in accordance with [Table 3C](#).
4. [Monthly service charges](#) are calculated on unpaid Fall Term fees in October, and calculated on unpaid Winter Term fees in December.
5. There may be additional [ancillary fees](#) levied for enrolment in specific courses or for individual circumstances. Check your invoice on ACORN.
6. the normal length of a Degree program is four years for students who do not take an International Foundation Program year and/or a Professional Experience Year Co-op. Students who exceed the normal length of their program will be charged the same tuition as students in the final year of the program.
